## Instructions for requesting a W-2 Transcript (or) Verification of Non-filing Letter

If you do not have copies of your W-2's, you may request a W-2(Wage) Transcript from the IRS:

- 1. Call 1-800-829-3676 and follow the instructions below:
  - Choose language preference
  - Select option #3 for "other tax information"
  - Select option #1 for "personal and individual tax questions"
  - You will then be connected with an IRS employee. If you need a W-2, request a Wage Transcript as well.
  - You will then be transferred to the appropriate department to process your request.

**Note:** You can request that the documents be faxed or mailed. Mailed documents arrive in 5-10 days.

**2.** You may complete Form 4506-T: Request for Transcript of Tax Return (or) Verification of Non-filing Letter. To request a W-2/Wage Transcript use check box 7. Fax or mail the form to the number or address indicated on the form. A printable PDF of Form 4506-T is available on MCC's financial aid website (<a href="www.milescc.edu">www.milescc.edu</a>) and on the IRS website (<a href="www.milescc.edu">www.milescc.edu</a>).

Note: Requesting a W-2/Wage Transcript is free of charge. Most requests are processed within 10 days

2. Online tax information can also be found at the <a href="IRS website">IRS website</a> (<a href="www.irs.gov/Individuals/Get-Transcript">www.irs.gov/Individuals/Get-Transcript</a>) using transcripts online. If you have never filed taxes, or do not have the required information for the security clearance, then you will need to choose option 1 or 2 above.
