Instructions for requesting a W-2 Transcript (or) Verification of Non-filing Letter

If you do not have copies of your W-2's, you may request a W-2(Wage) Transcript from the IRS:

1. Call 1-800-9089-9946 and follow the phone prompts
- 2 . You may complete Form 4506-T: Request for Transcript of Tax Return (or) Verification of Non-filing Letter. To request a W-2/Wage Transcript use check box 7. Fax or mail the form to the number or address indicated on the form. A printable PDF of Form 4506-T is available on MCC's financial aid website (www.milesc.edu) and on the IRS website (www.irs.gov).

Note: Requesting a W-2/Wage Transcript is free of charge. Most requests are processed within 10 days

2. Online tax information can also be found at the [IRS website \(www.irs.gov/Individuals/Get-Transcript\)](http://www.irs.gov/Individuals/Get-Transcript) using transcripts online. If you have never filed taxes, or do not have the required information for the security clearance, then you will need to choose option 1 or 2 above.
