



International Student Certificate of Finance

The United States Citizenship and Immigration Services (USCIS) agency requires Miles Community College to verify that international students receiving a Form I-20 have sufficient financial support to pay for their expenses while studying in the United States. The MCC Admissions Office requires a full completed Certificate of Finance form and proof of sufficient liquid funds for each international student applicant as per the guidelines listed on page 2 of this form.

Sufficient funds are defined as liquid funds equivalent to or great than the estimated academic year expenses listed on the MCC Admissions website. Documentations of funds provided must be dated within the last two months.

Miles Community College reserves the right to request official documents to be resubmitted or sent via postal mail if they cannot be verified as authentic/original statements. MCC reserves the right to request additional documentation if documentation sent by student does not meet our requirements. MCC reserves the right to accept documentation that may not meet all guidelines below but is still deemed sufficient by MCC. An I-20 will not be issued until sufficient financial support documents are received.

MCC will accept the following document types as proof of funds for issuing a Form I-20. All documents must be translated into English.

1. Official Bank Letter - Must include the following:

- Issued on official Bank Letterhead
- Date letter was issued not more than 2 months
- Account Holder Name
- Account Type (ex. checking, savings, educational/bank loan)
- Date Account was opened
- Account Balance
- Signature/Stamp from a bank representative

2. Bank Statements – Must include the following:

- Previous 6 month of bank statements for the account
 - Statement Date
 - Account Holder Name
 - Account Type
 - Type of Currency
 - Current Account Balance – converted to USD (Should match Bank Letter)
- * If your Registered Education Savings Plan, RESP account is not through a bank, the letter is not required

3. External Scholarship Award Letter or Student Loan Approval Letter – Must include the following:

- Scholarship/Loan Name
- Date of the award availability
- Recipient’s full name
- Amount of Scholarship or student loan
- List of fees/expenses for which the award can be used
- Signature/Stamp from scholarship organization/representative or loan agency

4. Miles Community College Athletic Scholarship

- Please request that your coach to send your Athletic Award directly to the MCC Admissions Office.

Unofficial documentation that will **NOT** be accepted:

Investment statements, retirement statements, IRA accounts, life insurance statements, solvency certificates, tax returns, non-liquid assets (such as property, jewelry, a business, etc.), account statements from another F-1 student, paycheck stubs, proof of employment letters, or any unsigned/unstamped bank letters or scholarship awards.
